## **Subject: Invitation for Bids - Medical Benefit Scheme req.**

The Corporation is proposed to subscribe Mediclaim policy from IRDA recognized Insurance companies for extending Medical benefits to the employees of the corporation including their dependents to cover hospitalization and Lab test charges etc. Interested health/medical insurance policy providers may quote their most reasonable premium rates for annual coverage limit of Rs.5 lakhs, Rs.4 lakhs, Rs.3 lakh per family for senior management, middle management and other executives respectively. The salient features of the policy which should mandatorily cover the following points may also be submitted along with the quotes:

1. Availability of Cashless reimbursement Medical policy (list of hospital) Pan India basis coverage;
2. List of diseases not covered, capping for any specific procedure and minimum mandatory hours of hospitalization may be confirmed.
3. Individual + Spouse + Parents + Children (three) Coverage;
4. Coverage from date of issue of policy on a pan India basis;
5. Ambulance charges coverage limit;
6. Pre and Post hospitalization expenses coverage (No. of days);
7. Accidental coverage;
8. Dental Coverage;
9. Maternity cases coverage;
10. Pre-medical examination for existing diseases, if required – please specify;
11. Coverage of Day care procedures;
12. Organ donor;
13. Family transport facility coverage
14. Addition/ deletion facility (due to resignation by employee)
15. Exclusion, if any

You are therefore, requested to submit your quote along with:

- (i) The validity period of quotes of Insurance Company (Quotes from brokers firms or any other nature shall not be entertained.);
- (ii) The company must certify / submit an undertaking that they are following the guideline of IRDA; etc for issue of group health insurance considering 50 employees (200) plus members / their dependents as per list in the prescribed perform **latest by 4th May, 2018**.
