## **National Backward Classes Finance & Development Corporation (NBCFDC)**

### **Partnership with Non-Govt. Organizations/Voluntary Organizations for mobilization of Beggars for Skill Development Training ensuring NSQF & Common Norms of Ministry of Skill Development & Entrepreneurship (MSDE) for Beggars**

#### **I- Background**

National Backward Classes Finance & Development Corporation (NBCFDC) is a Government of India undertaking under the aegis of Ministry of Social Justice & Empowerment (SJ&E). Authorized share capital of NBCFDC is Rs. 1500 Crore against which the Ministry has so far released Rs. 1184.00 Crore. NBCFDC was incorporated on 13 January, 1992 under Section 8 of Companies Act 2013 (earlier Section 25 of the Companies Act, 1956) as a Company not for profit with an objective to promote economic and development activities for the benefit of Backward Classes and to assist the poorer section of these classes in skill development and self employment ventures. Member of Backward Classes having annual family income less than double the poverty line as defined from time to time (presently Rs. 98,000/- in rural areas and Rs. 1,20,000/- in urban areas) are eligible to obtain loan and undergo Skill Development Training under NBCFDC Schemes.

The Corporation facilitates the Skill Development Training for the same target groups for ensuring self and wage employment and wage enhancement as mentioned in the Common Norms issued by MSDE, Govt. of India and any other guidelines that may be issued from time to time. The Skill Development Training Programme (SDTP) scheme of the Corporation may be viewed in our website [www.nbcfdc.gov.in](http://www.nbcfdc.gov.in).

## **II – PRESENT REQUIREMENT**

1. Ministry of SJ&E has entrusted the job of Skill Development Training Programme for members of begging community(of age not less than 18 Years) on pilot basis for the Financial Year 2017-18 to NBCFDC.
2. The main objective of the proposed Skill Development Training Programme is to upgrade the skill of members of beggar community to enable them to start income generating activities of their own or to get gainfully employed.
3. Skill Development Training will be provided by Govt. Institutes/Sector Skill Councils (SSCs) following the Common Norms of Ministry of Skill Development & Entrepreneurship (MSDE).through 100% funding by NBCFDC.
4. The various Training Institutions / Sector Skill Councils with whom NBCFDC has established linkages may be viewed in our website link [www.nbcfdc.gov.in](http://www.nbcfdc.gov.in).
5. The beneficiaries will be additionally paid stipend of Rs 1000/-per month during the period of training in terms of NBCFDC scheme. Subsequent to training the beneficiaries will be awarded certificate aligned with NSQF and all out efforts made to provide them self/wage employment opportunities.
6. NBCFDC is planning to provide Skill Development Training to about 500 beggars on Pan India basis as part of the pilot project.

## **III – Purpose of EOI**

1. NBCFDC invites Expression of Interest from Non-Government organizations (NGOs)/ Voluntary Organizations (VOs) and other institutes not for profit, working for the welfare of the beggar community for mobilizing the trainees for Skill Development training Programmes as detailed above.
2. Towards the same the agency would require to mobilize members of begging community not numbering less than 30 staying in close proximity for skill training programme in any particular skill of their choice.
3. The basic documentation of the beneficiaries such as proof of age, aadhar details and any other documents as available will also require to be consolidated by the NGO/VO.
4. The agency will also require to handhold the beneficiaries during the course of training and motivate them to complete the course, undergo assessment and to the extent possible, also avail employment opportunities.

5. For carrying out the above activities the NGOs/VOs would be paid mobilization and motivation charges of Rs 500/- per beneficiary for all those who successfully undergo the training programme.
- 6. It is to be explicitly noted that the NGOs/VOs are to apply against this EOI only for mobilization and handholding of beneficiaries for training programme and not for undertaking the training.**

#### **IV – WHO CAN APPLY**

Any agency can submit the EOI for mobilization and handholding of members of begging community for skill development programme subject to fulfillment of following conditions:

1. They have been in existence of more than 3 years and have a registered NGO/ Institute/Voluntary organization/Entity not for profit.
2. They have duly audited financial statements upto financial year 2016-17.
3. They have carried out atleast one project for socio-economic upliftment of the beggar community which could include rescue or rehabilitation activities.

#### **V – HOW TO APPLY**

Interested NGOs/VOs may apply with following details:

1. Documents of Registration / Incorporation as NGO or an agency not for profit.
2. Audited financial statement of FY 2015-16 and 2016-17.
3. Brief project report on Socio economic upliftment project for beggars implemented by agency.
4. Details of members of begging community who can be mobilized for skill training by the NGOs/VOs prescribed proforma at (Annexure-1)

#### **VI – Process for Empanelment**

1. Based on submission of the relevant documents to the satisfaction of NBCFDC, the qualified agencies will be invited for an interaction with the designated committee of the NBCFDC.
2. Subsequently NBCFDC will enter into a MoA with the shortlisted NGOs detailing the mutual responsibilities for facilitating training of the beggar community.
