A huge percentage of total population comes under this category. Therefore, in absence of their active participation, Country can not grown as it would be. In this regard, the Govt. of India has taken initiatives and formed a Corporation with an objective to promote economic and developmental activities for the benefit of members of Backward Classes living below double the poverty line through State Channelising Agencies (SCAs) nominated by respective State Govt./Union Territories. The Corporation was established not for profit under Section 25 of the Companies Act, 1956 (now under Section 8 of the Companies Act 2013) on 13th January 1992, named as 'National Backward Classes Finance & Development Corporation' (NBCFDC) under the then Ministry of Welfare (now known as Ministry of Social Justice & Empowerment), Govt. of India.</p> <p>The Corporation provides soft loan to the poorer section of Backward Classes living below double the poverty line and to assist in skill development and self employment ventures. The Company operates within the economic and other criteria fixed by the Govt. of India from time to time. The Financial assistance is provided to the members of Backward Classes, as notified by the Central and State Govt.</p>
